**Conditions of Use (continued)**

1. **Playability of Field (Rainouts):** Artificial turf fields play rain or shine except when there is lightning. The use of the reservation is subject to the playability of the field. Where conditions are questionable due to rain, playability must be confirmed before you use the field. Check our website at [www.sfrecpark.org](http://www.sfrecpark.org) for the most up to date information. If a Department representative is on site, you must follow instructions.
2. **Emergency Contacts:** You can reach our office Mon-Fri from 9am-5:30pm and Sat from 9am-12noon. After hours call Park Patrol at (415) 242-6390 if fields are booked or if there is disruptive behavior.
3. **No Dogs:** Dogs are not allowed on any athletic fields.
4. **Trash/Litter:** You are responsible for cleaning up all litter left on the field during your reserved time and taking your trash home with you. Failure to leave field litter-free may result in loss of future reservation privileges. If a previous user left garbage on the field, please let us know by calling 311.
5. **Reservations Required:** You must have this reservation confirmation with you at time of use.
6. **Cancellations or Changes:** Single reservations can not be cancelled or changed. Rainouts will result in a credit you must call our office within 2 business days to request them. For multiple use reservations, see our [reservations and policies](#). This reservation may be revoked or altered at any time for any emergency reason by the Recreation and Parks Department. Locations, dates and times may be changed by the Department.
7. **Activities on Field:** Persons on fields must refrain from gambling, profane language, quarreling or using alcohol beverages. Reservation holder may not charge admission, solicit monies, use a bbq or sell food, beverages merchandise without specific permits. Please contact 834-5510 to obtain permits. You must follow the instructions any Recreation and Park Dept director on site regarding activities on the field.
8. **No Assignment:** This reservation may not be assigned or transferred. Violations of any of the above conditions will result in depriving the Reservation Holder of further use of facilities.
9. **Liability for Use:** The above name Reservation Holder agrees to reimburse any person (including the Department) who sustains property damage, such as broken windows, for the cost of that damage, where such damage occurs on public or private property when such damage is caused by the use of this facility. In addition to the Licensee, the person who is representing the Licensee agrees to be personally liable.

**Special Field Rules for Synthetic Fields:**

The use of synthetic fields is subject to certain conditions listed below.

1. **No Food:** Eating food, drinking alcohol, chewing gum and sunflower seeds are prohibited on synthetic turf fields.
2. **No Smoking or Barbeques:** Fire of any kind is not allowed.
3. **Stay Clean and Healthy:** Wash your hands and any cuts, scrapes or turf burns after play.
4. **No Bikes, Metal Cleats OR Golf:** Bicycles, motorcycles, skateboards, roller blades, metal cleats, sharp objects and golf play may tear the turf and are not permitted on the field.
5. **Roll Goals:** To move goals in place, roll them across the field using the wheels. Don't move goals alone or small children to move them. Dropping the wheels is a 2-person job. Watch your fingers!
6. **Adhesives:** Adhesives like tape and line markings will damage the turf and are prohibited without specific consent from Recreation and Parks.

Violations of any of the above conditions will result in depriving the Reservation Holder of further use of facilities.

The Recreation and Park Department encourages park patrons to use alternative forms of transportation when visiting our facilities. Large groups and athletic teams are encouraged to car pool and ride share when possible.
