3. A 25% nonrefundable deposit is due immediately and must be paid within 3 business days or this reservation will be cancelled. Full payment of the balance is due at least 30 days prior to the season start or event date. Refunds/Credits will only be made in the event of rain or field closure. After final payment has been made a 25% refund of the full rental amount will be granted if a field is returned at least 7 business days prior to season start or event start date.
4. DOGS ARE NOT ALLOWED ON ANY ATHLETIC FIELDS.
5. This reservation may be revoked or altered at any time for any emergency reason by the Recreation and Parks Department. Locations, dates and times may be changed by the Department.
6. You must have this reservation confirmation with you at the time of use.
7. Persons on fields must refrain from gambling, profane language, quarreling or using alcoholic beverages.
8. Licensee may not charge admission, ticket monies, sell food, beverages or merchandise without specific permits. Please contact 831-5510 at least 30 days in advance to obtain a license.
9. You must follow the instructions of any Recreation and Park Dept director on site regarding activities on the field.
10. This reservation may not be assigned or transferred.

Violations of any of the above conditions will result in depriving the Licensee of further use of facilities.
